### AK - Alaska Bar Association, MCLE

#### CLEs outside of Alaska

CLE programs which take place outside of Alaska or are webcast from outside of Alaska are not required to be accredited by the Alaska Bar Association. Alaska Bar members may claim credit for attendance at CLE programs offered in or from other jurisdictions if the program has been accredited by another MCLE jurisdiction. CLE providers may not advertise programs as accredited by Alaska unless the program has been accredited by Alaska regardless of where the program is held.

AL - This course or a portion thereof has been **approved** by the Mandatory Continuing Legal Education Commission of Alabama for a maximum of 25.5 hours' credit, including 2.0 hours of ethics

AR - The Office of Professional Programs advises that Arkansas is a **Reciprocity State** - accepting hours approved by other states that have a 60 minute per credit hour requirement.

- DE - The Commission on Continuing Legal Education has **approved** the 73rd Annual Workers' Compensation Educational Conference for 25.5 credit(s), including 2.00 Enhanced Ethics credits.

  - (2) The course or activity is approved by an approved jurisdiction. If the above criteria are met you need not submit an application for course approval to the Hawaii State Board of Continuing Legal Education. Active members may claim credit for the course or activity to the same extent as in the approving jurisdiction.

**IL** - WCI has not applied to become an Illinois CLE provider.

**What are the criteria that allow an attorney to apply for Illinois CLE credit for an out-of-state course?**

If the course provider is not an Illinois Accredited Provider and chooses not to apply to accredit an individual course in Illinois, attorneys may apply to claim Illinois CLE credit for attending certain out-of-state courses. Here are important details:

**Courses beginning on or after 9/27/11:**

The attorney may apply online to claim Illinois CLE credit for attending the course if:

1. The course was held in person in the U.S. but outside Illinois and:

- o In a state with a comparable MCLE accreditation process\*, and the course was accredited for CLE credit in that state, or
- o In a state, or the District of Columbia, without a comparable MCLE accreditation process, and the course was accredited for CLE credit in any other state with a comparable MCLE accreditation process. OR

2. The course was held via live audio or live video and it was accredited for CLE credit in any state.

**IN** - The Indiana Supreme Court, Office of Admissions and Continuing Education, has **approved** the 73rd Annual Workers' Compensation Educational Conference for a total of 37.5 General credits, including 2.00 Ethics credits, and 12 NLS hours. The Office of Admissions and CE will need to have specific courses that any Indiana attorney attends listed on attendance as many topics were deemed NLS.

**KS** - The Kansas Continuing Legal Education Commission has determined that "due to the nature and scope of the presentation, we prefer that attorneys apply individually. The attorney will need to complete an application for approval of CLE activity and attach an agenda highlighting the sessions attended. Once this information is received, the program will be reviewed for possible credit."

**KY** - The Kentucky Bar Association has approved the 73rd Annual Workers' Compensation Educational Conference for 25.5 Total CLE Hours, including 1.0 Ethics Hours.

**NH** - For all programs taken after June 30, 2014:

- Courses will **no longer be certified** by the NHMCLE Board; course providers will not be submitting information to the state.
- *Attorneys* will **self-certify** program adequacy and **self-report** activity.

**NJ** - **Supreme Court Of New Jersey Board On Continuing Legal Education (FAQs)**  
([http://www.judiciary.state.nj.us/cle/att\\_faq.html#9](http://www.judiciary.state.nj.us/cle/att_faq.html#9))

New Jersey attorneys who are satisfying the CLE requirement of another mandatory CLE state or who take courses approved for CLE by another state will receive 1:1 credit for courses approved in that jurisdiction through reciprocity. However, attorneys should be aware that there are differences in requirements from state to state. Attorneys relying on reciprocity must ensure that they are also meeting the requirements of New Jersey's program. For example, New Jersey requires that four credits be taken in courses related to ethics, professionalism and/or professional responsibility. In addition, half of the required credits must be earned from attendance at live courses with the instructor physically in the same room as the participants. A course taken that has not been approved in a mandatory CLE jurisdiction will not have the benefit of reciprocity.

**NM** - Did not apply for NM CLE

**NV** - The Nevada Board of CLE has **accredited** the 73rd Annual Workers' Compensation Educational Conference for 21.00 credits, which includes 2.00 ethics credit and 1.0 substance abuse credit.

**NY** - **Reciprocity Statement: Effective November 1, 2014**

Under New York's Approved Jurisdiction policy, so long as certain requirements are satisfied, New York attorneys may count towards their New York CLE requirement credit earned through participation in out-of-state courses accredited by a New York Approved Jurisdiction. The policy applies to both traditional live classroom-format and nontraditional-format courses (online, DVD, teleconference, etc.). Traditional live classroom-format courses are out-of-state if they take place outside of New York State. Nontraditional-format courses are out-of-state if the sponsor organization is headquartered outside of New York State.

**OH** - The Supreme Court of Ohio has **approved** the 73rd Annual Workers' Compensation Educational Conference for 25.5 General Hours and 3.0 Attorney Conduct Hours.

**OK** - The Oklahoma CLE Commission has **approved** the 73rd Annual Workers' Compensation Educational Conference for: 29.50 Total Credit, which includes 2.50 Legal Ethics credit; 29.50 General.

## MEDIATOR CREDITS

Pursuant to the Administrative Order entered by Chief Justice Major B. Harding on 9-11-98 (effective 4-1-00), among other requirements, mediator certification renewal on or after 4-1-02, requires a minimum of 16 hours of Continuing Mediator Education (CME) credits to be completed, and shall include a minimum of 4 hours of mediation Ethics, 2 hours of Interpersonal Violence, and 1 hour of Cultural Diversity in each two year renewal cycle, including the two years following initial certification.

All PMI programs are 60 minutes to meet CEU requirements, so mediators are able to report 1.0 hour of PMI program time as 1.2 CME and/or CLE hours. CME/CLE credit time is shown in parentheses. This program provides up to 7.0 (8.4) hours of "General" Continuing Education Training credits, PLUS up to 4.0 (4.8) hours of Ethics, 2.0 (2.4) hours of Interpersonal Violence, and 1.0 (1.2) hour of Cultural Diversity. There's also 1.0 (1.2) hour of Technology time for attorneys needing that CLE credit.

1. Mediators must be registered for the conference to receive credit.
2. Mediators must check in at the CLE booth.
3. A Certificate of Attendance shall be provided at the PMI table.
4. Mediators self-report hours to their areas of certification at the time of their renewal.
