## OSHA and Heat Stress Panel: Where are we and where are we headed?

Regulating both indoor and outdoor heat stress has been a focus of federal OSHA during the last few years. This focus has been highlighted by the extensive, national media coverage of OSHA efforts and the concerns of employers. As heat stress is an issue that affects numerous employers across a wide variety of industries, those concerns are not without merit. OSHA has traditionally used the General Duty Clause to cite employers for heat hazards, but such efforts have presented significant hurdles for OSHA when tested in the courts. ## Engaging Employees Using Perception Surveys to Improve Safety Climate

## OSHA and Heat Stress Panel: Where are we and where are we headed?

Regulating both indoor and outdoor heat stress has been a focus of federal OSHA during the last few years. This focus has been highlighted by the extensive, national media coverage of OSHA efforts and the concerns of employers. As heat stress is an issue that affects numerous employers across a wide variety of industries, those concerns are not without merit. OSHA has traditionally used the General Duty Clause to cite employers for heat hazards, but such efforts have presented significant hurdles for OSHA when tested in the courts. In response, OSHA has taken steps to create a specific rule on indoor and outdoor heat stress. This session will provide participants important information on where we're at with respect to federal OSHA's regulation of indoor and outdoor heat stress and legal pitfalls for employers to avoid. 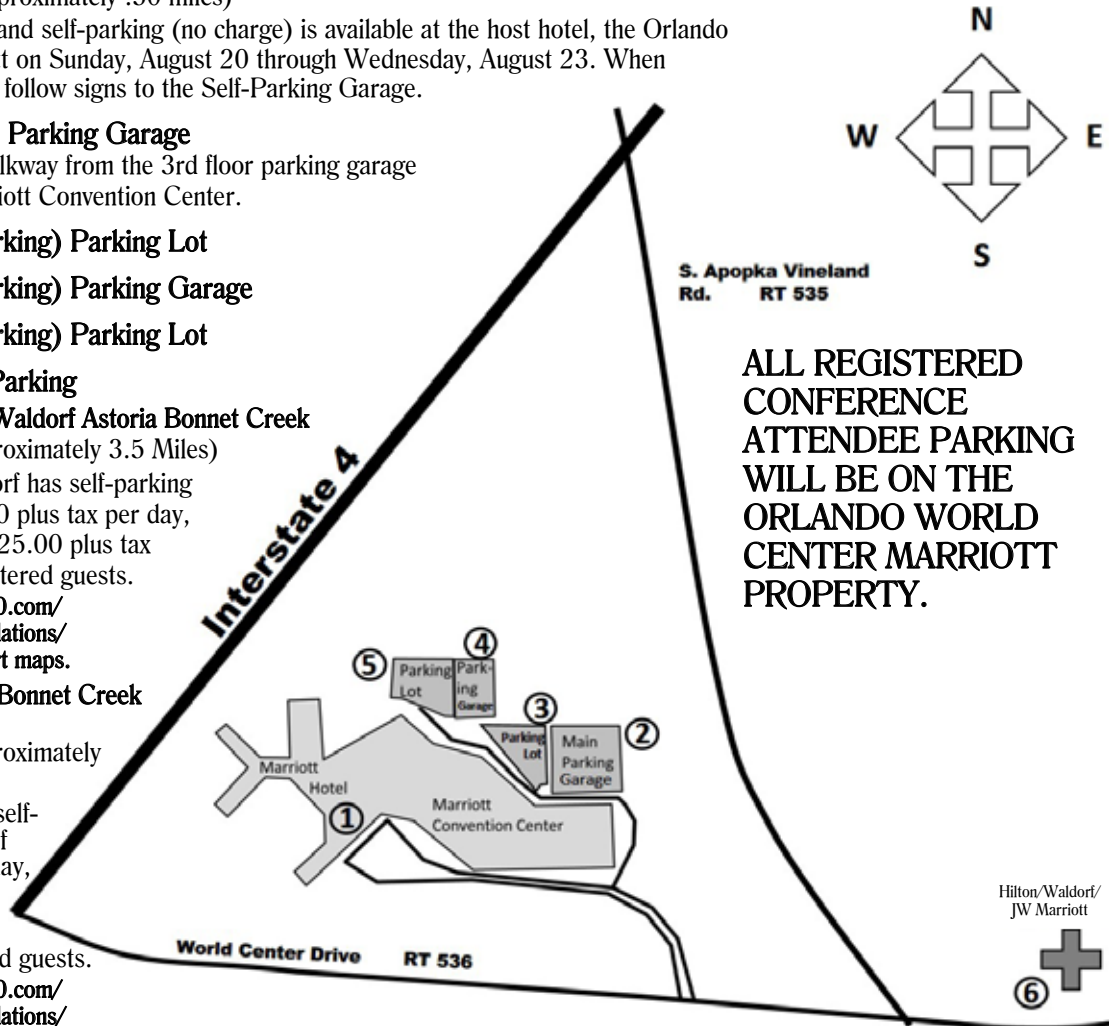

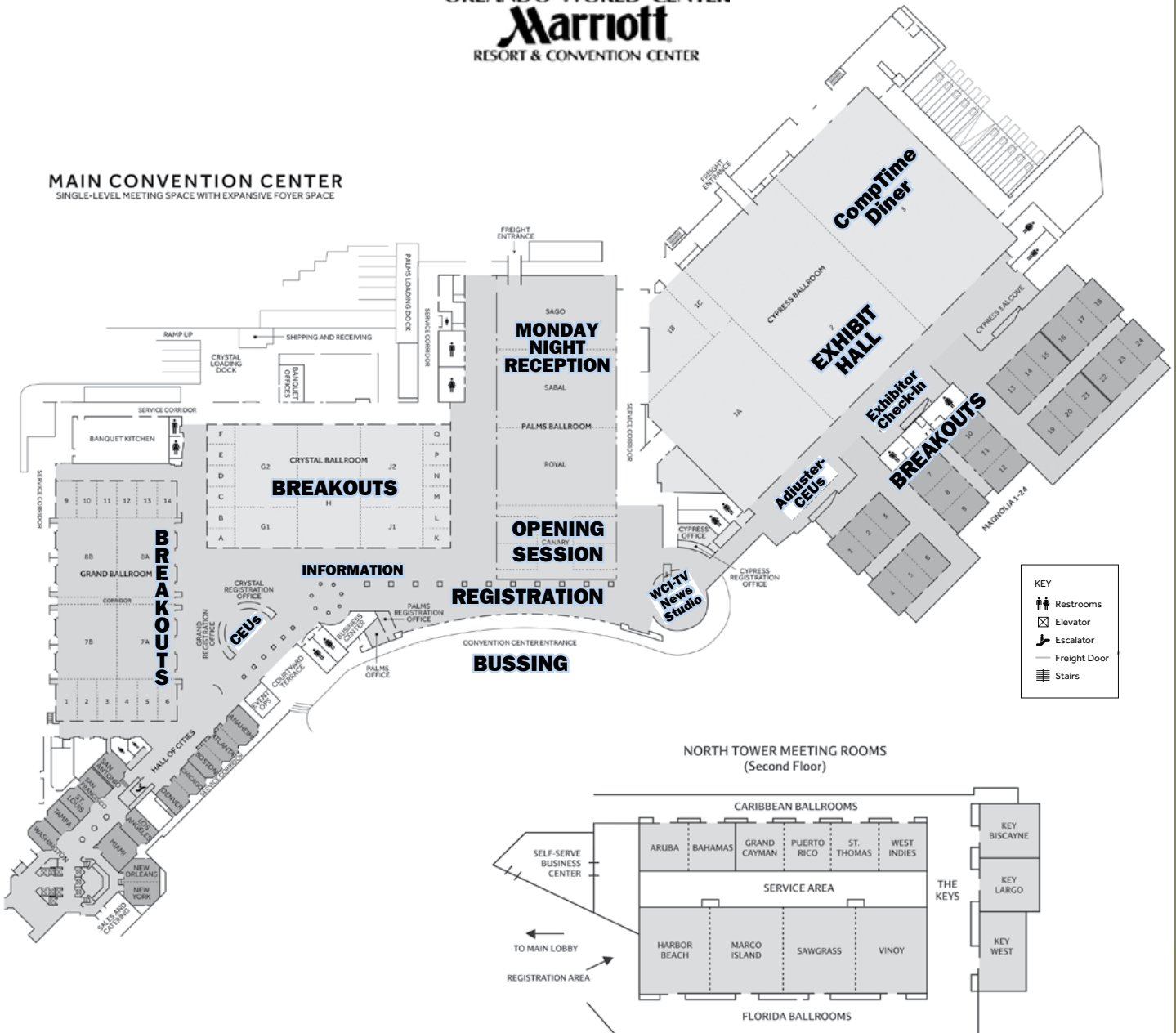
